- With Ideal via the Digital Tax Desk at www.veldhoven.nl/english/municipal-tax-assessment.

• At the town hall. Make an appointment for this at <u>www.veldhoven.nl/english/paying-municipal-taxes</u> or call 14 040.

Are you unable to pay the assessment (now)?

- You can apply for exemption within six weeks from the date of the assessment. There are rules for this. You can find more information on www.veldhoven.nl/english/exemption and via the Digital Tax Desk.
- You can also pay the assessment in more instalments. You can arrange this with the municipality. Send an e-mail to <u>gemeente@veldhoven.nl</u> or call 14 040.

Lodge an objection

Do you disagree with the assessment? Then you can lodge an objection within six weeks of the date of the assessment. In the meantime, you must pay the assessment as usual.

How to manage your municipal taxes



Digital Tax Desk

In the Digital Tax Desk (Dutch only) at www.veldhoven. nl/english/municipal-tax-assessment you can view your data. You can also arrange your municipal taxes yourself. Such as registering a dog, applying for remission or arranging direct debit. Use your DigiD to log in.

Your municipal tax assessment in Message Box

The municipality of Veldhoven is connected to the Message Box (Berichtenbox) at mijn.overheid.nl. This is your personal, secure mailbox for digital mail from government organizations. In the Message Box you can receive your tax demand from municipality of Veldhoven. Use your DigiD to log in. In the Message Box you can select the government organisations from which you want to receive digital messages. Select the municipality of Veldhoven. If you do this before February 1st 2025, you will receive the assessment for next year in your MijnOverheid message box.

How to request the valuation report of your property?

You have access to the valuation report immediately via:

- MijnOverheid (for homeowners): log in with DigiD. Click on Wonen > Bekijk WOZgegevens > peildatum 1 januari 2023
- The Digital Tax Desk with DigiD.

Market trends and the WOZ value

Based on the WOZ value (property valuation) and the ozb rate (property tax rate), we determine the amount of property tax you have to pay. The WOZ value is the resale value of the property on January 1st of the previous year: the value reference date. So for the WOZ value for tax year 2024, the legal value reference date is January 1st, 2023. What is currently happening on the housing market does not yet affect the WOZ value for tax year 2024. To determine the WOZ value, the municipality examines selling prices of comparable houses in the period from one year before to one year after the value reference date:




Attachment municipal tax assessment

Contact a WOZ employee

Do you disagree with the assessed WOZ value? Or do you have any questions? Please contact us within 3 weeks after the date of the tax assessment. You can do this as follows:

- Scan the QR code above or go to www.veldhoven.nl/english/objection-to-tax-demand.
 Fill in the online form *Contact WOZ-waarde 2024* (Dutch only) via de green button "Contact about the WOZ value 2024".
- Or send an e-mail to gemeente@veldhoven.nl. In the subject line, put "Contact WOZ value". In your e-mail, include the claim number, your phone number and the address.
- Or call 14 040. Keep the above information at hand. One of our employees will contact you within a few working days. Do you disagree with the outcome of this contact? Then you can submit an objection.

Objecting to the WOZ value

You can easily and quickly file an objection yourself. This is how to do it:

- Scan the QR code above or go to www.veldhoven.nl/english/objection-to-tax-demand.
 Fill in the online form *Bezwaar indienen WOZ* (Dutch only) via the green button "File an objection to the WOZ value".
- Or send us a letter explaining why you do not agree with the WOZ value. Our website contains a sample letter that you can use. Please do not forget to sign the letter. Send your letter to the tax officer of the municipality of Veldhoven, Postbus 10101, 5500 GA Veldhoven.

Please note: this objection must be filed within six weeks after the date of the tax assessment. If you object, you still have to pay the assessed amount. Overpaid taxes will be refunded.

Why file your own objection?

There are agencies that file objections to the WOZ value on your behalf "free of charge". But objecting to the municipality is always free of charge. The agencies do a lot of advertising. They work on a no cure, no pay basis. When handling these objections, the municipality must pay the agencies a considerable fee. These costs are ultimately charged to the Veldhoven taxpayer.
